 Consolidated Profit after tax in Quarter II/2024 was 267.94 billion VND and decreased by 744.13 billion VND compared with the same period in 2023 (of which consolidated profit after tax in Quarter II/2023 was 1,012.08 billion VND). The main reason is that in this period, the Company recorded less revenue from industrial park business activities compared to the same period last year.

- The parent company's separate profit after tax in Quarter II/2024 was 57.37 billion VND and decreased by 963.0 billion VND compared with the same period in 2023 (of which separate profit after tax in Quarter II/2023 was 1,020.37 billion VND). The main reason is that in this period, the Company recorded less revenue from industrial park business activities compared to the same period last year.
