RESOLUTION OF THE BOARD OF DIRECTORS

BOARD OF DIRECTORS KINH BAC CITY DEVELOPMENT HOLDING CORPORATION

- Pursuant to the Law on Enterprises No. 59/2020/QH14 approved by the National Assembly of the Socialist Republic of Vietnam on 17/6/2020 and documents amending, supplementing and guiding the implementation;
- Pursuant to the Enterprise Registration Certificate No. 2300233993 first registered on 27/3/2002, registered for the 21st adjustment on 03/10/2024 of Kinh Bac City Development Holding Corporation issued by the Department of Planning and Investment of Bac Ninh province;
- Pursuant to the current Charter of Kinh Bac City Development Holding Corporation;
- Pursuant to Submission No. 2001/2025/KBC/TTr-HDQT dated 20/01/2025 on approving the establishment of the Environmental, Social and Governance (ESG) Subcommittee;

RESOLVE:
